A meeting of the Essex County Board of Taxation was held on Monday, January 11, 2016 at 9:24 a.m. at its office, 50 South Clinton Street, Suite 5200, East Orange, NJ.

1. ROLL CALL

Upon roll call, the following members were present: Commissioner Johnson presided over the meeting, Present were DeFuria, Grodman, Linares, Matarazzo, Jr., Stewart and Administrator Durkin. President O'Brien was absent.

2. Approval of December 14, 2015 Minutes

Commissioner DeFuria made a motion to approve the minutes for the December 14, 2015 meeting. Commissioner Grodman seconded the motion. All were in favor.

3. Approval of December 18, 2015 Conference Call Minutes

Approval of the December 1, 2015 conference call minutes were adjourned to next scheduled Board Meeting on February 4, 2016.

4. File 2016 Tax List

Kenya Kourkoulis called the 2016 Tax Listing filing for the 22 municipalities. All filed with the exception of Orange and Newark. The City of Newark has request an extension to file on January 15, 2016. (Township of Orange tax list filed after completion of the Board Meeting)

5. Newark Requesting Extension to January 15 to File Tax List

Discussion regarding 400-condominium complex that had to be manually corrected for tax list. Motion to approve Newark requesting extension to January 15, 2016 was made by Commissioner Stewart. Seconded by Commissioner Grodman. All were in favor with the exemption of Commissioner Johnson who abstained.

6. Update Nutley Tax Assessor

The Board welcomed Patrick Wilkins, CTA the new Nutley Tax Assessor.

7. Resolution to Adopt Change Fund

Commissioner Johnson read into the minutes the Resolution to Adopt the Change Fund; Commissioner Grodman made the motion to approve the Resolution and Commissioner DeFuria seconded the motion. All were in favor.

8. Status of Revaluation for Caldwell and Essex Fells

<u>Caldwell</u>

George Librizzi, Tax Assessor informed the Board the delay in the process of the Revaluation is the tax maps. After the completion of corrections, he hopes to have approval from the State to move forward. Discussion was had regarding approval of tax maps and funding.

Essex Fells

Kevin Esposito, Tax Assessor informed the Board the process of updating the Tax Maps is in the final stages.

9. Revaluation Orders for Belleville, Maplewood, Millburn, Montclair, Nutley & South Orange

Maplewood and South Orange

Edward Galante, Maplewood Tax Assessor and Ellen Malgieri, Tax Assessor both requested to perform a Reassessment with 100% inspections instead of a revaluation for the year 2017. The cost factors of reassessment and 100% inspections on all property, shared school district, etc. were discussed.

<u>Belleville</u>

Kevin Esposito, Tax Assessor informed the Board that at the Township Counsel meeting scheduled for tomorrow the Revaluation will be addressed.

Millburn

Lisa Baratto, Tax Assessor informed the Board that the drafting of a proposal for a contract to have tax maps updated is in the process.

Montclair

George Librizzi, Tax Assessor informed the Board revision of the tax maps is being worked on.

Nutley

Patrick Wilkins, Tax Assessor stated that tax maps are good with some updates to be completed.

10. Letters from Maplewood & South Orange Requesting Reassessment with new forms

11. Resolution Changing Orders from Revaluation to Reassessment for Maplewood and South Orange

Commissioner Johnson read into the minutes a copy of Resolution dated January 11, 2016 permitting a Reassessment for 2017 with 100% inspections for Maplewood and South Orange.

A motion to approve the request for the Townships of Maplewood and South Orange to be allowed to perform a Reassessment instead of a Revaluation for the year 2017 was made by Commissioner DeFuria. Commissioner Matarazzo seconded the motion. All were in favor with Commissioner Grodman abstaining.

12. Update of Deeds

Kenya Kourkoulis informed the Board that as of December 31, 2015, 7,134 deeds keyed into the system. That is approximately an increase of 700 from this time last year.

13. Bloomfield – Willow Manor Condominium

Administrator Durkin informed the Board that a letter dated December 22, 2015 was received with regard to the separation of a master deed for the Willow Manor Condominium complex in Bloomfield.

Joe Pisauro, Tax Assessor stated that the issue of tax payment has been resolved with the help of the Tax Collector. Discussion followed regarding separation of master deeds, payment of taxes, etc.
